

Win your Deck, Fence or Roof Rules and Regulations:

Contest Dates

May 1– August 31, 2024

Eligible Products

Eligible products are all decking, fencing, and deck rail materials, including fasteners and construction hardware/materials. Installation charges and delivery fees do not qualify for this promotion and will not be refunded.

All eligible items must have been purchased on the same invoice

How Customers Enter

Customers can fill out one of the entry forms in the ballot boxes in-store at the retail it was purchased

All entries must be on or before August 31, 2024. Limit of one entry per person.

Rules and Regulations

How to enter: To enter and receive one (1) Contest entry: Customers can fill out one of the entry forms in the ballot boxes in-store at the retail it was purchased. The following retailers are eligible locations to enter: Big River Home and Building, Nipawin Home and Building, Prince Albert Home and Building, Shell Lake Home and Building, Shellbrook Home and Building, and Wakaw Home and Building.

Qualifying Products: All decking, fencing, and deck rail materials, including fasteners construction hardware, and materials and roofing materials, are eligible. Please note that deck and fence installation and delivery fees do not qualify for this Contest, and will not be refunded. Supporting products for decking or fencing installation (deck screws, joists, etc. bought on the same invoice) qualify for the Contest. However, Deck, Fence, and Railing accessories are not included in this contest.

Eligibility: To enter the Contest and be eligible to win a prize in the Contest, a person must be a resident of Saskatchewan and the age of majority in the jurisdiction in which he or she resides as of the Contest Start Date. Employees are eligible to participate in this promotion.

Prize: One (1) rebate cheque up to a maximum of \$5,000 CDN on the purchase of eligible products. The prize will be in the form of a cheque from the local Co-op. Labor, installation, and delivery fees do not qualify for this contest. APPROXIMATE RETAIL VALUE \$5,000.00 CDN. The chances of being selected are dependent upon the total number of eligible entries received during the Contest Period.

Prize Winner: A random draw will be made on September 1, 2024, by the Administrator from among all eligible entries received on or before the Contest Closing Date. There will be only three winners.

Selected entrants will be contacted by email and/or telephone within seven (7) business days of the draw date by a representative of the Sponsor or Administrator. If a selected entrant cannot be contacted within seven (7) business days of the draw date his/her entry will be disqualified and another entrant will be randomly selected.

Disqualification. The Sponsor and Administrator reserves the right to disqualify any person or cancel one or more entries of any person entering this contest or who attempts to participate by means contrary to the rules herein or in a manner prejudicial to other participants (e.g., use of Entry Forms obtained from an unauthorized source, entries exceeding the allowable limit, computer hacking, etc.). Any attempt to deliberately damage the Contest Website or undermine the legitimate operation of this Contest is a violation of criminal and civil laws. If such an attempt is made, the Sponsor reserves the right to seek damages from that person, without prejudice to the rights of the Sponsor to seek any other remedies to the extent permitted by law. This person could be referred to the competent judicial authorities.

Non-compliance/eligibility. By entering the Contest, entrants agree to abide by these Official Rules and the decisions of the Sponsor concerning all aspects of the Contest, which are final. This Contest is subject to all applicable federal, provincial, and municipal laws. Any selected participant who does not comply with these eligibility conditions must inform the Sponsor, Administrator or their respective representatives as soon as they contact him or her.

Acceptance of a Prize. All Prizes must be accepted as described in these rules and cannot be transferred to another person, substituted for another prize, or exchanged.

Refusal to accept a prize: The refusal of a person selected at random to accept a Prize according to the terms herein releases the Sponsor from any obligation related to the Prize to that person.

Personal information. The Sponsor respects your privacy. By entering the Contest, you consent to the collection, use, and disclosure of your personal information. Subject to Section 12(xii), the personal information provided by participants in connection with this Contest is being and will be used by the Sponsor and/or by third-party service providers on behalf of the Sponsor (including the Administrator) only to administrate and conduct this Contest, including determining eligibility and awarding and delivering the Prize, and for no other purpose. No communication, commercial or otherwise, unrelated to this Contest will be sent to a participant unless the participant expressly authorizes it.

Identification of the participant. For the rules herein, the participant is the person whose name appears on the Entry Form (or elsewhere, such as on a request for participation without purchase). It is to this person to whom the Prize will be awarded if he or she is selected and declared the Prize Winner.
