

Spring Into Summer Promotion – Have a chance to win \$30K in prizes!

- 1) **GAME DATES:** The Game begins at 12:01am CST on April 1, 2026 (the “Game Start Date”) and is scheduled to end on May 31, 2026 at 11:59pm CST (the “scheduled Game End Date”). The period between the Game Start Date and the scheduled End Date is known as the “game period”.
- 2) **WHO CAN PLAY:** The Game is open to all legal residents of Saskatchewan who are Lake Country Co-op members. You will be eligible to participate and win if you become a member during the game period. Employees and Delegates of participating retail locations, as well as those persons that reside with any Team Member and Delegate are not eligible to win the consumer prizes. There is a separate prize for Team Members and Delegates only. Board of Directors and Senior Leadership (directors included) as well as those persons that reside with them are not eligible to win prizes in the Game.
- 3) **HOW TO PLAY:** Go to any participating Lake Country Co-op location at any time throughout the Game Period and purchase the qualifying items. At the time of purchase, the cashier will provide entry forms and you will put it in the draw box. The Game is no way sponsored, endorsed, or administered by, or associated with Facebook, Instagram, or Twitter.
- 4) **QUALIFYING ITEMS**
Within the Game period, the items listed below qualify as an eligible entry.

- 6) **NOTIFICATION AND REDEMPTION:** If you have been selected as a potential winner in any of the drawings as described above, the Game Sponsor will notify you via email and/or phone. As a condition of receiving any prize, winner must have signed and returned, within seven (7) days of receipt, the Game Sponsor's Statement of Compliance, Release, and Indemnity Agreement under which, among other matters, winner confirms their compliance and eligibility with these Official Rules, completes, releases, and indemnifies Game Entities. In addition, claimed winners must have correctly answered the mathematical skill-testing question on the Release Form.
