

## Spring Into Summer Promotion – Have a chance to win \$28K in prizes!

- 1) **GAME DATES:** The Game begins at 12:01am CST on April 1, 2025 (the “Game Start Date”) and is scheduled to end on May 31, 2025 at 11:59pm CST (the “scheduled Game End Date”). The period between the Game Start Date and the scheduled End Date is known as the “game period”.
- 2) **WHO CAN PLAY:** The Game is open to all legal residents of Saskatchewan who are Lake Country Co-op members. You will be eligible to participate and win if you become a member during the game period. Employees and Delegates of participating retail locations, as well as those persons that reside with any Team Member and Delegate are not eligible to win the consumer prizes. There is a separate prize for Team Members and Delegates only. Boards of Directors and Senior Leadership (directors included) as well as those persons that reside with them are not eligible to win prizes in the Game.
- 3) **HOW TO PLAY:** Go to any participating Lake Country Co-op location at any time throughout the Game Period and purchase the qualifying items. At the time of purchase, the cashier will print a duplicate receipt and you will put it in the draw box. The Game is no way sponsored, endorsed, or administered by, or associated with Facebook, Instagram, or Twitter.
- 4) **QUALIFYING ITEMS**  
Within the Game period, the items listed below qualify as an eligible entry.

April 1 – 30, 2025 – World’s Finest Chocolate Almonds – All locations

May 1 – 31, 2025 – Hawkins Cheezies 210g – All locations

May 1 – May 14 – with the purchase of a Co-op Car Wash, receive a bonus entry (Nipawin and Prince Albert Touchless Car Wash locations)

May 8 – 22, with the purchase of any greenhouse item, receive a bonus entry (Prince Albert location)

April 1 – May 31, 2025:

- C-Store/Gas Bar locations – purchase of minimum 30 litres of fuel (includes regular, premium Top Tier, and diesel. Cardlock locations purchase up to 200 litres. Bulk Fuel litres are not eligible to win.
- Wine, Spirits, Beer locations – purchase of Spring into Summer items
- Home & Building Centres – Purchase of garden and/or seasonal items, purchase during the April Tool Event promotion, and participating in the Customer Experience Survey
- Food Stores – Purchase of any in-store meat item

- Pharmacy locations - purchase of World’s Finest Chocolate Almonds or Hawkins Cheezies

5) **PRIZE DRAWS DETAILS:** There are a total of twelve (12) prizes available to be won. All winners will be randomly selected for each prize drawing from among all eligible ballot entries received. If selected as a business until prize winner, you will be ineligible to win in the Grand Prize draw. All non-winning ballots will be discarded immediately in the appropriate manner.
